. Based on the references 1st to 3rd cited, this University has directed the institution to obtain the permission from the State Government of Tamilnadu to start Allied Health Science Degree Courses from the academic year 2020-2021 onwards.

2) In the reference 4th to 10th cited, the University has granted Provisional Affiliation to MMM College of Health Sciences, Chennai for the following Allied Health Science Degree Courses in the academic year 2010-2011, 2012-2013, 2014-2015 and 2015-2016.

4) In the reference 12th cited, in Resolution No.51 passed at the 287th Governing Council Meeting held on 22.12.2021, it was resolved:

"To issue the orders of Continuance of Provisional Affiliation / Conditional Continuance of Provisional Affiliation to Medical, Dental, AYUSH, Pharmacy, Nursing, Physiotherapy, Occupational Therapy and Courses under Allied Health Science stream by conducting inspection through Virtual mode in the first two months of 2022 and to ratify the action of University in having informed the seat matrix to the Selection Committee for the academic year 2021-2022".

5) In the reference 13th cited, in Resolution No.42 passed at the 292nd Governing Council Meeting held on 03.08.2022 it was resolved:

"To grant orders of Continuance of Provisional Affiliation / Conditional Continuance of Provisional Affiliation for the academic year 2022-2023 to those institutions for which relevant Orders of Affiliation has been granted for the academic year 2021-2022 (Based on the data submitted in the Affiliation portal and Virtual Inspection conducted)) to conduct Medical, Dental, AYUSH, Nursing, Pharmacy, Physiotherapy, Occupational Therapy, Allied Health Sciences and Post Doctoral Fellowship Courses as the seat matrix has to be issued to the Selection Committee".

Based on the resolutions, institutions have been instructed to upload the necessary documents in the Affiliation module of CMS2. Further, the documents submitted by the institution was verified by the Expert team for considering the grant of CCPA for conducting AHS Degree Courses for the a.y. 2021-2022 & 2022-2023.

- 6) The seat Matrix has been informed to the Selection Committee for the academic year 2021-2022 and 2022-2023 pertaining to only Government institutions.
- 7) The said institution has remitted the requisite fee for the academic years 2021-2022 and 2022-2023.

ORDER:

In pursuance of the Resolution passed by the Governing Council, data uploaded in the CMS2 portal, opined by Expert Committee and on receipt of requisite fee for the academic year 2021-2022 and 2022-2023, the University grants the Conditional Continuance of Provisional Affiliation to MMM College of Health Sciences, Tulip Avenue, 36/1, Annai Indra Nagar, Golden George Nagar, Magappair East, Chennai 600107 for conducting Allied Health Science degree courses for the academic year 2021-2022 and 2022-2023, subject to the following conditions:

- i To fulfill all the requirements (infrastructural, teaching and other facilities available) uploaded in the CMS2.0 portal.
- ii To rectify any other deficiencies is found later in the data submitted in the portal2.
- iii To abide the prescribed Rules / Guidelines of the Statutory bodies / Government of Tamil Nadu and the Affiliation Statutes of the Tamil Nadu Dr. M.G.R. Medical University, Chennai, imposed from time to time.
- iv The University may conduct inspection to verify the above if required and
- v The usual conditions already intimated in the Provisional Affiliation orders of this University and pending submission of DTCP approval.
- vi The seats available in Allied Health Science degree courses shall be filled as per the orders in force. The Management shall follow a transparent and reasonable method of admission for the management quota as per orders in force.
- vii The admission procedure as laid down in the G.O. of Health and Family Welfare Department, Chennai should be followed strictly. Any admission made over and above will not be permissible on any account.
- viii The approval from the relevant council (Rehabilitation of Council of India / Atomic Energy Regulatory Board) should be produced every year to consider further Continuance of Provisional Affiliation.
- ix Any other condition which the University considers necessary to impose from time to time should be followed strictly.

II) Instruction to the Institution issued Vide this University's letter dated 27.10.2021

- 1 Institutions or Hospitals with minimum 3 years of existence alone can start Allied Health Science Courses Under the Tamil Nadu Dr.M.G.R.Medical University.
- 2 Institutions without inpatient facilities will not be permitted to start AHS courses from Academic year 2021-2022. No tie up is permitted.

- There shall be 4 categories of Institutions 30 hedded, 60 hedded, 100 hedded and 200 hedded.
 - A 30 bedded speciality hospital can conduct one course.
 - A 60 bedded hospital can conduct maximum of 3 clinical courses (including 2 postgraduate courses) and 2 non-clinical AHS courses
 - A 100 bedded hospital can conduct maximum of 5 clinical courses (including 2 postgraduate courses) and 2 non clinical AHS courses.
 - A 200 bedded hospital can conduct maximum of 7 clinical courses (including 2 postgraduate courses) and 2 non clinical AHS course
- 4 The hospitals or institutions conducting AHS course should submit the records of last 6 months to the Inspection commission appointed by the University.
- The existing hospitals or institutions conducting AHS course with tie-up hospitals should comply with the new regulations (own hospital) within 2 years of time, until such time, new course/increase in intake will not be permitted. (To comply before 27.10.2023).
- 6 No. of hours of classes for each course should be specified.
- The programme of teaching and practical schedule should be submitted to the University once in 3 months for each batch of students as per the syllabus.
- Students feedback of courses should be obtained from each batch by the Unlliversity. For a one-year course 2 times, 2 year course3 times and for a three12 year course approximately 5 times and same should be stored and evaluatled at timely intervals/during inspections.
- A grievance redressal forum should be constituted and the details of the same should be displayed publicly in the institutions conducting the courses. The forum should meet at regular intervals.
- Outgoing students Job placement and job status should be collected on annual basis and updated in University and Institutional Web site.
- 11 Each institution conducting any AHS courses should have a web site- with details of courses, faculty, Job Opportunities, previous placements, grievance cell details etc
- 12 The University should evaluate the outcome and relevance of each course annually based on the grievance redressal forum, placement details etc. Decision regarding course relevance and continuation should be taken.
- Once in three years, the curriculum and syllabus of all the courses should be evaluated and revamped according to current scenario.

The institutions are instructed to comply with this norms for the academic year

2023-2024 onwards.
